- 3. Vendor shall have access to the location agreed upon by the parties not prior to 7:30am for setting up Vendor's vending station, goods, and other things necessary and reasonable to vending at the location.
- 4. Vendor shall have access to the location for up to 1 1/2 hours after the Event's conclusion at 4:00pm to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.
- 5. Vendor shall not vend any goods or services other than those described herein at and during the Event without the Host's written consent.
- 6. Vendor's outside space shall be no larger than 10 x 10 feet or taller than 10 feet; shall be clean and orderly; and shall comply with all applicable laws and regulations.
- 7. No loud music, noise, or sound amplification devices shall be used by vendor's staff at the location.
- **8.** All tables must be covered with a table cloth. Items such as knives, flammable items, and other inappropriate materials and items will not be permitted.
- 9. Vendor is responsible for collecting and payment of any state sales tax and for maintaining product liability.
- 10. A copy of the Insurance Certificate must accompany the application.
- 11. Vendors may unload at the side entrance of the church but then must park in designated area provided in parking lot.
